<p>The proposed action is located on the Seaview Range, approximately 65 km south-west of Ingham in North Queensland. The proposed action is located within Charters Towers Regional Council local government area. The proposed action is on the boundary of the Hinchinbrook Shire Council Shire, which is located to the east. The land is currently used for cattle grazing with limited pasture improvement or land clearing having occurred to date.</p>	
1.6 What is the size of the proposed action area development footprint (or work area) including disturbance footprint and avoidance footprint (if relevant)?	
<p>The Proposed Action has a total development footprint of 887 ha. The impact assessment has considered the development footprint to be the same as the disturbance footprint. This is the maximum area expected and will be refined and reduced through future detailed design. For eg. existing tracks are to be used but are included in the overall disturbance footprint at this time.</p>

Wind farm development require a material change of use (MCU) and operational works permit for the clearing of Regulated Vegetation. State Code 23 – Wind Farm Development provides the assessment and approval pathway for the MCU, with State Code 16 – Native Vegetation Clearing used for operational works assessments. All technical information required for the development permit is presented in one consolidated development application, submitted to the Department of State Development, Infrastructure, Local Government and Planning (DSDILGP), represented by the State Assessment and Referral Agency (SARA), as assessment manager.</p>		
<p>Under State Code 23, wind farm development should be appropriately located, sited, designed and operated to ensure that the development avoids, or minimises and mitigates adverse impacts on ecological values. Section 3

Description of the project area

3.1 Describe the flora and fauna relevant to the project area

The project area occurs within two bioregions, the Wet Tropics and the Einasleigh Uplands. The Wet Tropics Bioregion is diverse, with vegetation ranging from rainforest, sclerophyll forests and woodlands to shrublands, heathlands and mangroves. The Einasleigh Uplands vegetation consists predominantly of eucalypt woodlands.

Field surveys were conducted across two seasons to capture the natural variability and change in species activity and/or likelihood of detection that is experienced in the Wet Tropics and Einasleigh Uplands Bioregions across seasons. Surveys consisted of

- Flora
 - o ground-truthing Queensland Regional Ecosystem (RE) mapping
 - o Secondary and quaternary assessments to collect data on vegetation characteristics (floristic and structural form) ecological condition and extent of the vegetation communities
 - o Targeted searches for threatened flora species
 - o incidental observations of weed species
- Fauna
 - o bird surveys
 - o active searches, including scat and track searches, den and roost site searches
 - o fauna area searches, spotlighting and call playback
 - o drone surveys
 - o harp and mist net trapping
 - o ultrasonic and acoustic detectors
 - o baited remote cameras
 - o scat analysis

Flora

The project area is predominantly covered by remnant vegetation and contains large tracts of well-connected native vegetation – mainly eucalypt woodlands, which are representative of the vegetation within the broader region.

One potential Threatened Ecological Community (TEC) was identified; Broad leaf tea-tree (*Melaleuca viridiiflora*) woodlands in high rainfall coastal north Queensland, however detailed survey indicated it does not meet the criteria for inclusion as a TEC.

Twenty-seven weed species were found during flora surveys. Most of these have limited distributions in the survey area (i.e. only occur in a few places/habitats), or are at low density; however some are more widespread and occur either in dense infestations or at consistently moderate density (refer Attachment B). *Praxelis clematidea* and *Mesosphaerum suaveolens* are the most pervasive species, having invaded most habitats and REs.

A full list of species in each ground-truthed RE within the survey area is provided in Att B – Ecology_Assessment

Fauna

A total of 204 fauna species were identified throughout the survey area, as summarised in Att B – Ecology_Assessment. This comprised 130 birds, 2 flying foxes, 25 microbat, 16 terrestrial mammals, 12 reptile species, 5 amphibian species & 8 Exotic fauna. A complete list of fauna species detected in the survey area is presented in Att B – Ecology_Assessment.

Nine threatened fauna were confirmed within the survey area:

- Sharman's rock-wallaby (*Petrogale sharmani*) (vulnerable)
- koala (*Phascolarctos cinereus*) (vulnerable)
- greater glider (*Petauroides volans*) (vulnerable)
- spectacled flying fox (*Pteropus conspicillatus*) (endangered)
- masked owl (northern) (*Tyto novaehollandiae kimberlii*) (vulnerable)
- red goshawk (*Erythrotriorchis radiatus*) (vulnerable)
- greater large-eared horseshoe bat (*Rhinolophus robertsi*) (vulnerable)
- bare-rumped sheath-tailed bat (*Saccopteryx saccolaimus nudicliniatus*) (vulnerable)

Although not detected during the field survey, the following species have potential to occur in the survey area due to the presence of suitable habitat:

- grey-headed flying fox (*Pteropus poliocephalus*) (vulnerable)
- white-throated needletail (*Hirundapus caudacutus*) (vulnerable and migratory)
- southern cassowary (*Casuarius casuarius johnsonii*) (endangered)
- Atherton delma (*Delma mitella*) (vulnerable).

Two EPBC Act migratory species, satin flycatcher and Latham's snipe were observed just outside the survey area (approximately 4 km west). Their close proximity and the occurrence of suitable habitat inside the survey area make these species relevant to this assessment.

A suite of migratory bird species has the potential to occur in the survey area. This includes:

- spectacled monarch, black-faced monarch, oriental cuckoo and rufous fantail, which all have potential to occur in the habitat type - simple notophyll vine forest.
- fork-tailed swift and white-throated needletail have potential to occur above the survey area, however these species

are almost exclusively aerial and they occur over a wide variety of habitats.

- barn swallow has potential to occur in paperbark woodland.

A high presence of feral predators such as cats and dogs were detected on remote cameras, with wild dogs also detected in acoustic recordings.

3.2 Describe the hydrology relevant to the project area (including water flows)

The survey area is traversed by numerous watercourses comprised of both minor drainage lines (stream order one) through to major watercourses (stream order five). The largest watercourse traversing the survey area is Michael Creek (Stream order five). The survey area lies within two separate drainage basins, Burdekin Basin (associated with the Einasleigh Uplands) and Herbert Basin (associated with the Wet Tropics).

3.3 Describe the soil and vegetation characteristics relevant to the project area

Twelve surface rock types occur in the survey area, granite being the dominant rock which forms more than half of the project area. Overall, rock formations across the project area are a combination of composite unit (dominantly stratified), intrusive unit and stratified unit (including volcanic and metamorphic). Soils within the project area are largely dictated by the corresponding surface geology. The predominant soil type within the survey area is sand to sandy loam over structured clay. There are also pockets of loam over sandstone and loam over granite.

The project area was ground-truthed to be predominately open forests and woodlands dominated by various mixes of Eucalyptus and Corymbia species. Shrub layers (dominated by Acacia species) are highly variable in density (soil and fire history are major determinants), and ground layers are dominated by grasses (mainly Themeda triandra and Heteropogon species). Small areas of species-rich vine thicket and simple notophyll vine forests occur, and major watercourses support well-developed riparian woodland communities with Casuarina cunninghamii and Melaleuca species.

One potential TEC was identified; Broad leaf tea-tree (*Melaleuca viridiflora*) woodlands in high rainfall coastal north Queensland, however detailed survey indicated it does not meet the criteria for inclusion as a TEC. No threatened flora species were recorded.

3.4 Describe any outstanding natural features and/or any other important or unique values relevant to the project area

The majority of the project area supports remnant vegetation. Over 200 native fauna species have been recorded including nine threatened species. The project area maintains good connectivity with neighbouring habitat areas including the Wet Tropics World Heritage Area located ~650m to the northwest.

3.5 Describe the status of native vegetation relevant to the project area

Vegetation within the project area is mostly in remnant condition with a few small pockets of non-remnant areas located along the southern border of the project area. A total of 69 Regional Ecosystems on six different land zones were identified, largely comprised of least concern vegetation.

Disturbances to vegetation within the survey area are from cattle grazing, weeds and roads/tracks. Grazing disturbance is concentrated on the lower, very open woodland habitats in the south of the survey area and is limited in all other habitats. Weeds are present throughout the survey in low to high densities. Other forms of disturbance are rare.

One potential TEC was identified; Broad leaf tea-tree (*Melaleuca viridiflora*) woodlands in high rainfall coastal north Queensland, however detailed survey indicated it does not meet the criteria for inclusion as a TEC. No threatened flora species were recorded.

3.6 Describe the gradient (or depth range if action is to be taken in a marine area) relevant to the project area

The gradient within the survey area ranges from 400-700 m above sea level. Various landforms occur across the survey area including basalt plains, low hills, ranges and granite plateaus.

3.7 Describe the current condition of the environment relevant to the project area

The survey area is predominantly covered by remnant vegetation and contains large tracts of well-connected native vegetation. Production from relatively natural environments (grazing of native vegetation) is the main land use of this area.

The remnant vegetation is predominantly in good condition, with some weed presence (ranging from low to high densities) throughout the survey area and grazing disturbance concentrated on lower, very open woodland habitats in the south of the survey area. Other forms of disturbance are rare.

Eight exotic pest fauna were observed through the survey area. A high presence of feral predators such as cats and dogs were detected on remote cameras, with wild dogs also detected in acoustic recordings.

3.8 Describe any Commonwealth Heritage places or other places recognised as having heritage values relevant to the project

There are no National Heritage places recorded on the project area, however there are National Heritage Places adjacent to the project area. Range View Nature Reserve, Lannercost State Forest and Giringun National Park are part of the Wet Tropics World Heritage Area (WTWHA), with WTWHA boundary <1 km from the edge of the project area.

3.9 Describe any Indigenous heritage values relevant to the project area

The project area is located on Gugu Badhun country. Gugu Badhun country encompasses the Upper Burdekin region of North Queensland and its catchment.

The Federal Court of Australia declared that Gugu Badhun people have 'maintained an on-going, unbroken cultural and spiritual connection to the land' which the Gugu Badhun people call Gugu Badhun country. The Native Title Consent Determination recognised the Gugu Badhun people's native title rights and interests across more than 650,000 hectares (Cadet-James et.al 2017).

The proponent has been in ongoing consultation and undertaken community engagement with the Gugu Badhun people since February 2019. A MOU was reached in November 2019, and Cultural Heritage Management Agreement executed between Gugu Badhun and the Proponent in June 2020. Formal negotiations commenced in August 2020 on an Indigenous Land Use Agreement for the project; engagement remains ongoing with a view toward conclusion shortly. Refer Att A-MNES_Impact Assessment, Section 11.2.1, page 141.

3.10 Describe the tenure of the action area (e.g. freehold, leasehold) relevant to the project area

The proposed footprint is located on Lot 3198 Plan PH2177, which is surrounded by Lot 2 Plan SP205224, Lot 3 Plan WG274 and Lot 8 Plan SP104503. All lots associated with the project area are leasehold.

3.11 Describe any existing or any proposed uses relevant to the project area

The Proposed Action will occur within the Project area, which contains predominantly remnant vegetation and is subject to cattle grazing.

Section 4

Measures to avoid or reduce impacts

4.1 Describe the measures you will undertake to avoid or reduce impact from your proposed action

The Proposed Action will implement the environmental mitigation hierarchy of avoid, minimise and mitigate impacts to relevant MNES during the detailed design phase of the Proposed Action and will continue to implement this throughout the life of the Proposed Action. Details of the range of measures that will be implemented to avoid and reduce potential impacts is provided in Section 6 of the MNES Report (Att A-MNES_Impact Assessment). These are summarised below.

Avoidance through design has been the primary guiding principle to reduce impacts on protected values.

A detailed constraints analysis developed an ‘avoidance priority’ dataset, which was used to inform design. Constrained areas were ranked and then mapped as either no-go zones or priority accordance areas according to their ecological value for threatened species. The mapping identified areas where, from a biodiversity perspective, clearing should not proceed, be avoided as much as possible or undertaken only with mitigation strategies in place.

A comprehensive avoidance and mitigation measures will be delivered via the implementation of the Upper Burdekin Biodiversity Management Framework (BMF – provided as Att C - Biodiversity Mgmt Framework) and associated management plans. The BMF establishes suitable controls to eliminate or minimise the risks to the environment to a level that is low, negligible or reduced to as low as reasonably practicable. It provides the overview for the environmental management of the construction and operation phases of the UBWF.

The framework is comprised of:

- The overarching BMF, which sets out relevant statutory requirements; Windlab’s environmental policy and commitments; and implementation and compliance requirements across all environmental management plans.
- A Vegetation Management Plan (VMP), which details the environmental management requirements for managing impacts on vegetation during the construction stage of the Proposed Action.
- A Fauna Management Plan (FMP), which details the environmental management requirements for managing impacts on fauna during the construction stage of the Proposed Action.
- A Bird and Bat Management Plan (BBMP), which details the environmental management requirements for managing impacts associated with collisions risk during the operational stage of the Proposed Action.
- Additional avoidance and mitigation measures specific to MNES species are highlighted within the VMP and FMP.

There will be ongoing opportunities to further reduce the impacts to MNES as the final design of UBWF is development and these will be implemented in line with the constraints analysis and the BMF. Environmental offsets will be provided for any significant residual impacts to MNES. Early investigations and landholder discussions have been undertaken relating to offsets. There are large areas available on Kilclooney Station that contain the same suite of values as those present within the project area, and these locations will be prioritised for further offsets investigations in the first instance. There are also other options within the wider region that can be explored, as required. Offsets planning will be an important element of the next phase of the environmental impact assessment process.

4.2 For matters protected by the EPBC Act that may be affected by the proposed action, describe the proposed environmental outcomes to be achieved

The Proponent predicts the following outcomes for the Proposed Action:

- Habitat critical to the survival Sharman’s rock wallaby, koala, greater glider and red goshawk will continue to be available to these species within the project area.
- Important populations of Sharman’s rock wallaby, koala, greater glider and red goshawk will continue to be present in the project area.
- The availability of roost sites and foraging habitat will continue to be available to the bare-rumped sheathtail bat and masked owl.
- Foraging habitat suitable for the grey-headed flying-fox and spectacled flying-fox, will continue to be present in the project area.
- Foraging habitat suitable for the white-throated needletail, fork-tailed swift will continue to be available in the airspace above the project area.
- The limited available foraging and shelter habitat for Latham’s snipe will not be impacted.
- The risk of turbine strike will be managed throughout the operational life of the project and additional mitigation measures implemented as required and via the adaptive management framework in the Bird and Bat Management Plan.
- The Outstanding Universal Value and National Heritage values of the Wet Tropics will be maintained, without disruption from UBWF.
- A Biodiversity Management Framework will be implemented to avoid, minimise and mitigate potential UBWF impacts from within the project area, additionally benefiting the broader region including the Wet Tropics.

Significant impacts to world and national heritage values are not anticipated. These are also assessed in detail in the MNES Report (Att-A-MNES_Impact Assessment, Section 11) and are summarised below.

The impact assessment for World Heritage has taken into account the UNESCO retrospective statement on OUV, Indigenous heritage values, the threatening processes outlined in the Wet Tropics Conservation Strategy (WTMA 2004), results from technical impact studies commissioned for the UBWF project, and, other technical studies into the Wet Tropics flora and fauna. The key findings of the impact assessment are outlined below.

Key findings of WTWHA values assessment

National heritage values –

- The Gugu Badhun, the Traditional Owners of the project area, do not identify as Rainforest Aboriginal Peoples Aesthetic values (refer details in Att D-LVIA_Report_Part 1 to Part 6)
 - The Proposed Action development footprint is in a different Landscape Character Type than the adjacent WTWHA
 - o Includes both rural and natural attributes
 - o Does not have the same perceived naturalness and inaccessibility as the WTWHA LCT due to the steepness of the topography.

- The UBWF is highly unlikely to be viewed from within the WTWHA due to topography and/or dense vegetation

Natural heritage values

- Rainforest habitat and ecosystem - the project area is largely Eucalyptus woodland and open forest. Less than 1% supports vine forest vegetation community, different to the tropical rainforest underpinning the listing of the WTWHA
 - Flora species - , no species endemic to the Wet Tropics were recorded
 - Fauna - no species recorded in the project area are endemic to the Wet Tropics.
 - Some highly mobile threatened fauna recorded in the UBWF are known to also inhabit rainforest and may move between the project area and the WTWHA.

- o Species specific mitigation measures are to be implemented to avoid, mitigate and minimise impacts on these species

Threatening processes

- Measures are recommended throughout the MNES report in relation mitigating impacts to natural values within the project area
 - o Proposed Action is unlikely to compound threatening processes known to be a risk to the biodiversity and aesthetic values of the WTWHA.
 - As a renewable energy project, the UBWF will positively contribute to addressing the threat from climate change to the WTWHA
