The Licensee must ensure that the maximum biomass of wild caught Southern Bluefin Tuna (Thunnus maccoyii) on the Licensed Site does not exceed 5 tonnes.

3.

The Licensee must ensure that the maximum biomass of Licensed Species, other than wild caught Southern Bluefin Tuna (Thunnus maccovii) on the Licensed Site does not exceed 500 kilograms.

The Licensee must undertake an environmental monitoring program of the sea floor in relation to the Licensed Site when directed by the Minister in writing and in a manner and form determined by the Minister.

5.

The Licensee must carry out or cause to be carried out a regular in-situ cleaning regime for farming structures consistent with the Commonwealth of Australia Anti-fouling and In-water Cleaning Guidelines.
