INTRODUCTION

Oceanhill Pty Ltd (Oceanhill), a 100% subsidiary of UIL Energy Limited (UIL Energy), is the current registered title holder of Exploration Permit EP495 (the 'Permit').

The Permit was initially granted to BlackRock Mining (formerly Greenrock Energy) on 16 May 2016 and subsequently transferred to Oceanhill Pty Ltd under a Permit Sales Agreement, registered on 25 August 2016. On 09 September 2016, UIL Energy Limited acquired Oceanhill Pty Ltd and a 100% interest in EP495.

The following documentation has been prepared by UIL Energy Ltd on behalf of Oceanhill Pty Ltd. For simplicity, references to UIL Energy throughout this correspondence also refer to Oceanhill Pty Ltd, as the case may be.

UIL ENERGY STAKEHOLDER ENGAGEMENT

STAKEHOLDER ENGAGEMENT PROCESS

Stakeholder engagement with State Departments, Local Government Authorities, Native Title groups and Landholders for the Oceanhill 3D Seismic Programme commenced in 2013 (Greenrock Energy). UIL Energy, has since developed and implemented a stakeholder engagement strategy in accordance with Regulation 17 of the PGER Act 1967 and the Guideline for the Development of Petroleum and Geothermal Environment Plans in WA, 2016. The Principles of UIL Energy's stakeholder engagement strategy include:

- **Communication** Communication must be open, accessible, clearly defined, two-way and appropriate.
- **Transparency** The process and outcomes of community and stakeholder engagement should, wherever possible, be made open and transparent, agreed upon and documented.
- **Collaboration** A co-operative and collaborative approach to seek mutually beneficial outcomes is considered key to effective engagement.
- **Inclusiveness** Inclusiveness involves identifying and involving communities and stakeholders early and throughout the process, in an appropriate manner.
- **Integrity** Community and stakeholder engagement should establish and foster mutual trust and respect.

These principles have been adapted from the Ministerial Council on Mineral and Petroleum Resources (MCMPR) Principles for Engagement with Communities and Stakeholders (2005).

The outcomes of UIL Energy's stakeholder engagement strategy are recorded in UIL Energy's Stakeholder Consultation Register. Consultation to date has predominately comprised of meetings and correspondence with a number of State Departments, Local Government Authorities, Traditional Owners, Landholders and other organisations.

UIL Energy is committed to ongoing stakeholder identification, communication, engagement and consultation through all phases of the Project.

Key engagement to date is summarised in the accompanying Table.

CULTURAL HERITAGE PROTECTION – STAKEHOLDER CONSULTATION

Within EP495 there are two (2) registered Native Title Parties, the Amangu People and the Yued People, refer to *Attachment 1 – Figure 5: Land tenure*.

Oceanhill Pty Ltd have executed Exploration Agreements with both Native Title Parties for EP495. The Exploration Agreements set in place the required processes, protocols and commercial terms relative to conducting petroleum exploration activities within EP495 and the respective Native Title Claim areas.

For the Ocean Hill 3D Seismic Programme, the provisions of the Exploration Agreements require consultation for both the on-ground ecological survey (consistent with the definition of a "Low Impact Activity" [LOA)] under the Exploration Agreements) and the 3D Seismic Survey.

Oceanhill Pty Ltd provided the requisite prior notice of the on-ground ecological survey to both Native Title parties in October 2016. The Notice set out the nature and location of the survey, to assist both Native Title parties in assessing whether they had any 'reasonable concern' that the proposed on-ground ecological survey may impact or disturb an Aboriginal Site or Area of Cultural Concern. Neither Native Title Party indicated they had any such reasonable concern.

For the 3D Seismic Survey the consultation process requires a notice of the proposed seismic activity be provided to each Native Title Party prior to the commencement of the proposed activity, discussion with those Native Title parties, and the establishment of a Seismic Activity Monitoring Team. For a seismic survey commencing early Q1/2018, the Notice of Seismic Activity and the ensuing consultation must commence by the beginning of Q4/2017.

UIL Energy are committed to the preservation of Indigenous cultural heritage and artefacts. To meet this commitment UIL Energy will ensure UIL Energy operations and activities are carried out with due consideration to relevant Cultural Heritage legislation and to areas of cultural significance and that all workers, contractors and UIL Energy personnel are aware of their obligations in this regard. In particular:

- to never disturb or remove any items of cultural significance (eg. skeletal remains, stone artefact scatters, stone tools, shell middens, scarred trees, stone arrangements and rock art),
- to immediately report discoveries of items of cultural significance to the Native Title Party and the UIL Energy Site Representative who shall in turn report the findings to the Native Title Representative Body, the Heritage Council of Western Australia and the Department of Aboriginal Affairs (DAA);
- to ensure that in the event a discovery is made, that all workers stop work immediately, immediately report to the Native Title Party the location of the object, document the discovery with photos if able, mark the site (record the grid reference) and report the findings to the UIL Site Representative. Under no circumstances, do not take possession of or move any Aboriginal Object or undertake any activity that interferes with, damages, disturbs, alters or impacts upon an Aboriginal Object or an Area of Cultural Concern; and
- to give due consideration to cultural heritage issues and their significance in the wider community.
